

2010-2011 Financial Requirement for Applicants with Non-Immigrant Status

Under current United States Citizenship and Immigration Service regulations, international students must provide evidence of sufficient financial resources to support all living and educational expenses during their stay in the United States. In order to receive financial approval for admission and a Form I-20 or DS2019, an applicant must complete the Financial Form and provide all required documents to verify that sufficient funds are immediately available. Refer to the Financial Form for details. The University reserves the right to require tuition and/or housing deposits, if deemed necessary.

Students accompanied by their families will be asked to verify an additional \$4,000.00 per year for a spouse and \$3,000.00 per year for each child. These figures do not include travel expenses or tuition for other family members. The tuition and fees charged by SIUE are established by the University Board of Trustees and are subject to change without prior notice whenever conditions make such changes necessary. Students should anticipate an annual increase of five to seven percent due to inflation and other factors. The cost breakdown for the 2010-2011 academic year is as follows:
